Residents are required to registers small watercraft, such as kayaks and paddleboards in order to store at 42<sup>nd</sup> Street Beach Access Strip.

1. Hours of Use: Hours of watercraft use are 7:00am - Dusk
2. Watercraft Size Limitation: To protect shorelines, the maximum length of a stored watercraft will not exceed 12 feet in length. No family may register more than one watercraft.
3. Slot Assignment: Registration may not be assigned or transferred.
4. Storage Capacity: Watercraft storage capacity is limited and subject to change and/or additional rules implemented as adopted by the Town.
5. Registration Term: Registration is valid until November 1, 2018.
6. Revocation: Applicant understands that this registration is revocable at will. Furthermore, failure to comply with registration stipulations will trigger the removal of watercraft by the Town.
7. No watercraft shall be attached to private fences.

**WAIVER AND RELEASE OF ALL CLAIMS**

The applicant does hereby release the Town of Yarrow Point, its officers, officials, employees and volunteers from and against any and all claims for theft, vandalism, acts of nature, or any other damage or loss to personal property stored under this registration. It is understood by the applicant that there is no security of any sort provided by the Town at this facility and that all security in the form of locks will only be provided by the applicant. This registration does not grant any reservation of rights of exclusive use, nor does it imply any permanent interest or rights to future use and is revocable at will. The applicant hereby agrees to the terms contained in this agreement and agrees to hold the Town of Yarrow Point harmless for any damages, or losses arising from this registration and subsequent watercraft storage.
