**AN ORDINANCE OF THE TOWN OF YARROW POINT, WASHINGTON,  
AMENDING THE BUDGET FOR FISCAL YEAR 2021  
TO ACCOUNT FOR UNFORESEEN EXPENDITURES;  
AND ESTABLISHING AN EFFECTIVE DATE.**

**WHEREAS**, the Town Council adopted the Yarrow Point Town budget for fiscal year 2021 by Ordinance No.707 on November 10, 2020; and

**WHEREAS**; the beginning fund balances set forth in the 2021 budget were only estimated in 2020 and are now known in sum certain amounts; and

**WHEREAS**; certain expenditures and adjustments, the necessity and/or amount of which were unexpected by the Town, have occurred during the course of 2021; and

**WHEREAS**; new revenues and corresponding expenditures should be realized in and reflected by the adopted budget through an amendment thereof; and

**WHEREAS**, pursuant to RCW 35A.33.120, the Town Council finds that it is in the best interest of the Town to decrease all or portions of the total appropriations provided for certain funds as set forth in the adopted 2021 budget, and to re-appropriate the same for another purpose or purposes, as provided herein;

**NOW, THEREFORE BE IT ORDAINED BY THE COUNCIL OF THE TOWN OF YARROW POINT AS FOLLOWS:**

SECTION 1. The budget for the fiscal year 2021 is hereby amended as follows:

001 – General Fund	\$1,203,141	\$1,363,512
211 – Bond Redemption Fund	\$ 85,607	\$ 329,933
301 – Capital Improvement I	\$ 115,000	\$ 231,235
304 – Capital Improvement IV	\$ 115,000	\$ 231,235

SECTION 2. The 2021 budget is hereby amended in accordance with Section 1 of this Ordinance. The Clerk-Treasurer shall cause a copy of this Ordinance to be filed with the Auditor of the State of Washington, Division of Municipal Corporations, and with the Association of Washington Cities.

SECTION 3. If any section, subsection, sentence, clause, phrase or word of this ordinance shall be held to be invalid or unconstitutional by a court of competent jurisdiction, such invalidity or unconstitutionality shall not affect the validity or constitutionality of any other section, subsection, sentence, clause, phrase or word of this ordinance.


SECTION 4. This ordinance shall be in full force and effect five days after its passage and publication.

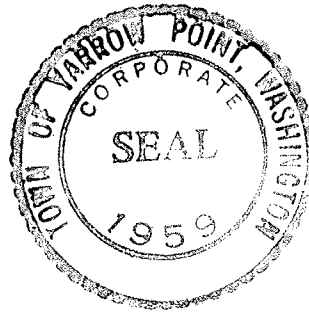
