

**TOWN OF YARROW POINT  
ORDINANCE NO. 728**

**AN ORDINANCE OF THE TOWN OF YARROW POINT, WASHINGTON,  
AMENDING CHAPTER 2.28 OF THE YARROW POINT MUNICIPAL CODE TO  
ESTABLISH THE COMMENCEMENT TIME AND LOCATION FOR REGULAR  
MEETINGS OF THE PLANNING COMMISSION; PROVIDING FOR  
SEVERABILITY; AND ESTABLISHING AN EFFECTIVE DATE.**

**WHEREAS**, the Yarrow Point Planning Commission has historically scheduled its regular meetings to begin a 7:00 p.m. on the Monday after the second Tuesday of each month and has held the meetings at Yarrow Point Town Hall; and

**WHEREAS**, Chapter 2.28 of Yarrow Point Municipal Code ("YPMC") sets forth regulations regarding the Planning Commission; and

**WHEREAS**, the Town Council now desires to amend Chapter 2.28 YPMC to formally adopt the date, time, and location for regularly scheduled Planning Commission meetings; and

**WHEREAS**, the Town Council finds the amendments as set forth herein to be in the public's interest, safety and welfare.

**NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE TOWN OF YARROW POINT, WASHINGTON AS FOLLOWS:**

**SECTION 1.** Findings. The foregoing recitals are hereby adopted as findings of fact in support of the adoption of this Ordinance.

**SECTION 2.** Amendment to Chapter 2.28 YPMC. Yarrow Point Municipal Code chapter 2.28 is hereby amended by the adoption of a new section to read as follows:

**2.28.030 Regular meetings.**


The Planning Commission shall meet in a regularly scheduled manner to conduct all business related to the Planning Commission on the third Tuesday of each month. All regularly scheduled meetings shall commence at 7:00 p.m. at Yarrow Point Town Hall, 4030 95th Ave NE, Yarrow Point, Washington.

**SECTION 3.** Severability. If any section, subsection, sentence, clause, phrase or word of this Ordinance should be held to be invalid or unconstitutional by a court of competent jurisdiction, such invalidity or unconstitutionality thereof shall not affect the validity or constitutionality of any other section, subsection, sentence, clause, phrase or word of this Ordinance.


**SECTION 4.** Corrections. The Town Clerk-Treasurer and codifiers of the ordinance are authorized to make necessary corrections to this ordinance including, but not limited to, the correction of scrivener/clerical errors, references, ordinance numbering, section/subsection numbers and any references thereto.

**SECTION 5.** Effective Date. A summary of this Ordinance consisting of its title shall be published in the official newspaper of the Town. This Ordinance shall take full force and effect five (5) days after the date of publication.
